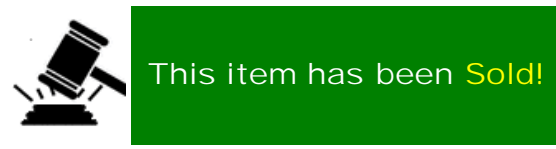

### Description for Item # 316225133

I am offering a Original Mauser Sporting rifle in 30/06. This rifle was made in 1912 by the serial number of 57,9XX. It has been reblued with some spots of rust after the reblue (mostly on the trigger guard). The bore is good with good lands but a little dark in the grooves. The receiver, trigger guard and floor plate numbers match. The bolt does not match and is a K98 type and was reblued with the rest of the rifle. It has the military double stage trigger pull and has a very light let off. The gun has the original sights and does not have any extra holes in the receiver. The Lyman peep sight was installed on the bolt release and is very cool and has a flip up peep for different size holes. It has a lever lock for changing ranges very fast and easy. The little wheel on the opposite side of the lever moves the elevator up and down for fine range adjustments. Looks like a very expensive sight for its day with lots of parts and functions. The stock is the correct type and is a original Mauser sporting rifle stock but the number does not match. I see no cracks and looks solid with the Mauser horn butt plate. The butt plate is chipped up some so look at the pictures. No bad for 100 years old. This gun is ready for the hunt in one of the greatest calibers ever. It should be checked by a gunsmith before firing. I will need a copy of your C&R or a FFL before I can ship. Shipping will be \$30 fully insured. Personal checks delay shipping two weeks but are welcome.

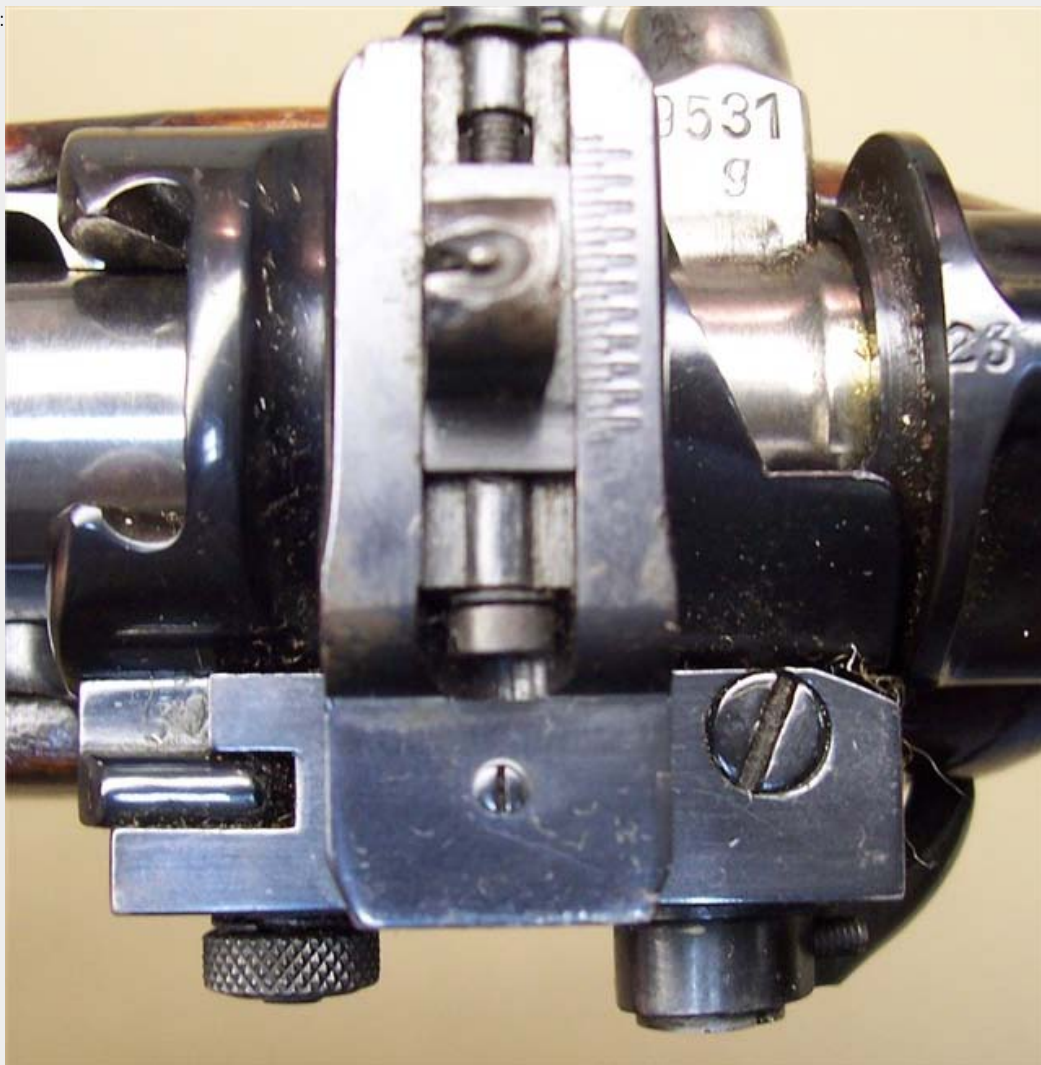

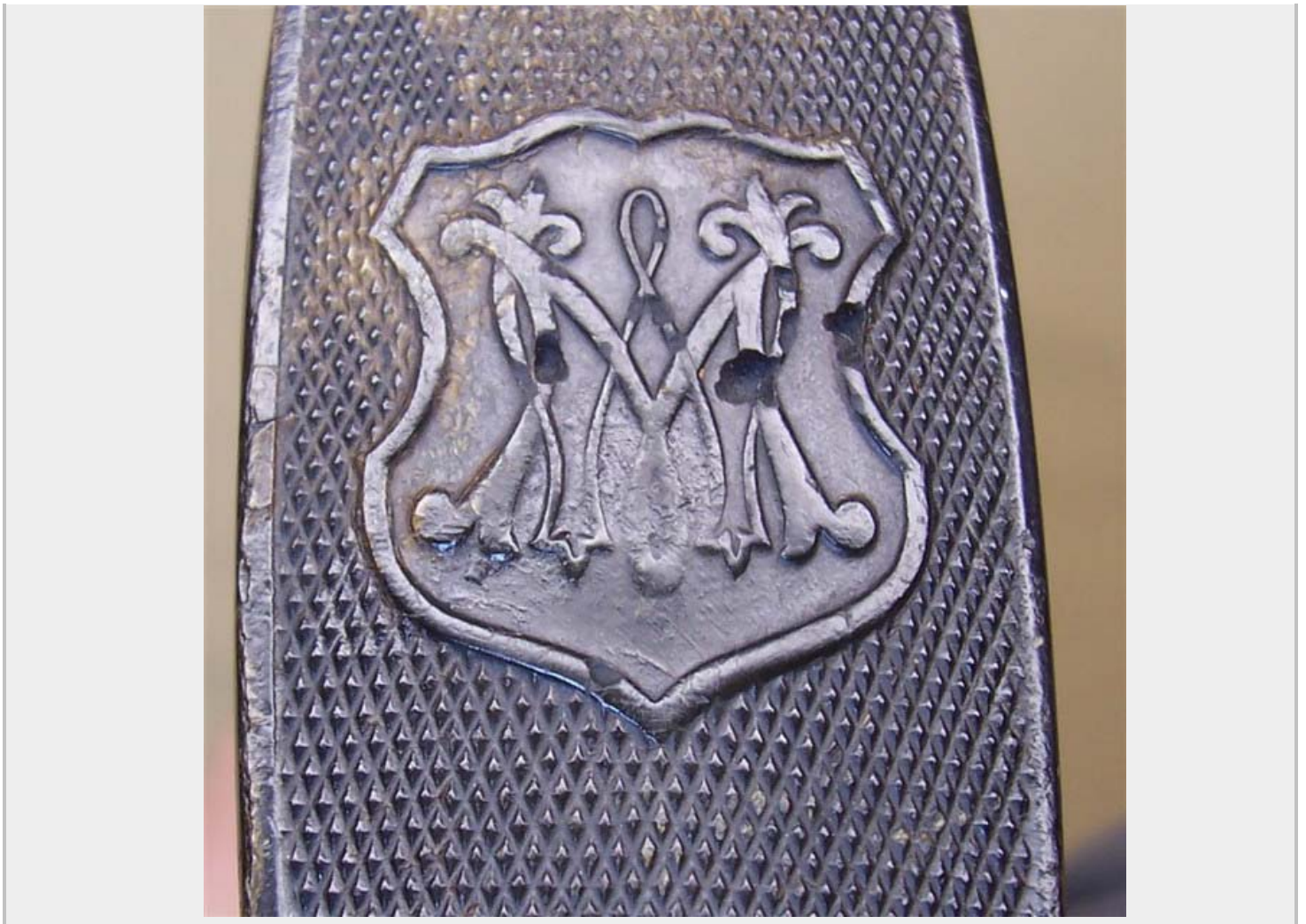
